Opens December 19, 2006

The newly renovated first and second floors of Philadelphia Park have been transformed into the temporary home of Philadelphia Park Casino. Patrons visiting on opening day were welcomed to the new "Racino" by the friendly staff of doormen, valets, cashiers and cocktail wait staff. The sights and sounds included beautiful decorations, plush red carpet, bells ringing, coins popping. 2100 slot machines are in place on the first and second floors.



# TAX STRATEGIES FOR POTENTIAL HORSE OWNERS

## II. FARM BUSINESS EXPENSES

### A. Ordinary and Necessary Expenses

A taxpayer is entitled to deduct all ordinary and necessary expenses for carrying on the business of farming. Breeding, raising, training, racing or showing horses is normally classified as a farming business.

### B. Methods of Accounting

Except for limited types of businesses specifically required to use the accrual method of accounting, a horse business can use the cash method of accounting. Thus, all taxable income is reported in the year it is actually or constructively received and farm expenses are generally deductible when paid.

**Tax Tip** - Cash method accounting allows horse owners to plan profitable years by deferring income to a later year and prepaying expenses earlier in the year.

### C. Deductible Expenses for Cash Method Horse Owners

Special rules available to farmers generally allow people in the horse business to deduct in the year paid the direct and indirect costs of breeding, raising, training, racing or showing of horses. This means that all necessary and ordinary expenses, including depreciation of fixed assets are deductible expenses.

Stud fees and training expenses are deductible in the year paid. They do not have to be capitalized, that is, they do not have to be added to the cost of the horse in calculating its tax basis.

Amounts paid for breeding fees, supplies, feed, etc. to be delivered and used in the following year can be deducted in the year paid. However, to be deductible when paid, the prepayments must have some business purpose and must not represent a deposit that will be applied to a future payment.

### D. At Risk Limitations

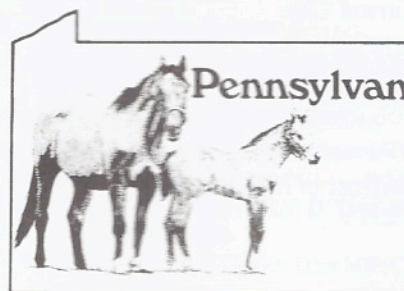
The amount of loss, which may be deducted by a taxpayer in connection with a farming activity, cannot exceed the aggregate amount of capital the taxpayer has at risk in that activity at year-end. Losses not allowed are suspended and allowed the next tax year and subsequent years to the extent the taxpayer has capital at risk.

**Tax Tip** - If you buy into a horse venture on an installment purchase, it is normally advisable to make sure that the installment payments are at least as much as your share of the depreciation deductions. ■

## A Disciplined Approach to Financial Success

**Organization...Discipline...Sense of Purpose.** They sound like qualities a football team would stress in preparing for the next weekend's opponent, but they can also be virtues in helping you achieve your financial goals.

Ideally, you should consult with a financial professional to map out a strategy. But with personal commitment and perhaps some sacrifice, you can take several steps on your own to help build a successful financial game plan.

**Know Yourself** – Take inventory of your finances. Calculate your assets – cash, IRAs, mutual funds, real estate, life insurance – and your liabilities, like a mortgage or consumer debt and deferred income taxes on investments.

**Take Stock of the Market** – Mutual funds are probably the best way to start in the stock market. Also, if you choose a fund, plan to stick with it for a while. Remember even the best financial pros have trouble timing the market.

**Curb Your Credit Cards** – If your total monthly debt payments (excluding your mortgage payments) are 20% or more of your monthly take-home pay, you're probably overextended.

**Be Wise with Windfalls** – If you come up with a significant lump sum – a bonus, an inheritance, or maybe even a mid-size lottery win – try to resist the urge to buy the hot sports car you've always dreamed of.
