A CELEBRATION OF PENNSYLVANIA RACING

AHEAD OF THE GAME — Sea Of Green wins Gallant Bob to add value for owner.

Janis Gerace had no problem joining the celebration of racing in the Keystone State even though she didn't have an entry in one of the six state-bred races that made up Pennsylvania's Day at the Races at Philadelphia Park on Oct. 6.

That was due partly to Sea Of Green, the colt she owns and trains, capturing the \$150,000 Gallant Bob Handicap at six furlongs on the same program.

But it also had to do with the desire of most horsemen and horsewomen to boost the breeding industry that supplies the stars of the sport that provides their living.

Gerace offers an example of the knowledge and skill required in determining the chances of success of lightly or unraced young thoroughbreds.

She bought Sea Of Green, a Florida bred, at a sale of two year olds at Calder for \$35,000. With his win in

the Gallant Bob, the colt raised his career earnings to \$449,912 with six wins out of 19 starts.


Keith Lebarron had even more reason to celebrate than most when Classic Verse, a gelding that races in his wife Susan's name, won the \$50,000 Devil's Honor Handicap for state breds at seven furlongs.

"T've been training for 26 years," said an overjoyed Lebarron, "and that was my first stakes win."

It was a day filled with the kind of excitement and surprises you can expect when eight of the 11 races on the program are stakes, including the \$250,000 Grade II Cotillion Handicap. Total purses for the eight stakes were \$700,000. The quality of racing drew a large crowd that matched the enthusiasm of the horsemen. Almost.

"I'm always a fan of state-bred races," said John C. Zimmerman, who trains Tradewinds Stable's Sir Echo, winner of the \$50,000 Yankee Affair Stakes at 1 1/16 miles on the turf, "especially when I get the biggest part of the pot."

Twenty minutes into the meeting, we were escorted out of the capitol building because of fear of a possible terrorist attack after the Twin Towers of the World Trade Center were destroyed in New York and the Pentagon in Washington was hit.

Mike, Sal and I attended a rescheduled meeting Oct. 10. I want

On Monday, Nov. 12, we met in Harrisburg with Representatives Karl Boyes and Frank Tulli Jr. on what else? — Slots.

President John Wames and Executive Director Todd Mostoller from the Pennsylvania Horsemen's Benevolent & Protective Association at Penn National also attended.

Then on Thursday, Sept. 15, we met on slots again, this time with State Senator Robert M. Tomlinson.

All of the meetings were very productive and signalled that the PTHA, in seeking a fair share from any revenues produced by proposed slots, is actively working for its horsemen and horsewomen.

Pennsylvania's Day at the Races on Saturday, Oct. 6 featured six stake races for registered state breds, each with a purse value of \$50,000, as well as the \$150,000 Gallant Bob Handicap for three year olds and the \$250,000 Cotillion Handicap for thee-year-old fillies (complete details in the accompanying story and in the results on Page 4).

DEATH OF A LOCAL CHAMPION

My Juliet, a champion filly who combined astonishing speed in sprints with stamina to win distance races against her era's best thoroughbreds, has died in Kentucky at the age of 29.

Her list of lifetime accomplishments is extraordinary. Eclipse Award-winning sprinter at 4 years old, the daughter of Gallant Romeo won 17 stakes during her magnificent career and banked \$548,859 in a time when money had much greater value. Some of her career highlights include a victory over the great Bold Forbes in the then Grade II Vosburgh Handicap of 1976 and a win at 5 over the boys in the 1977 Grade II Michigan Handicap at 1 1/8 miles.

While she won graded races around two turns, she also had

the ability to dazzle with an incredible turn of foot. She once went an opening quarter in an astounding 20.3 and was the long-time track record holder at six-and-a half furlongs at Philadelphia Park, where she was stabled and performed brilliantly. The mark of 1:14.3 for 6 1/2 furlongs stood for 22 years.

Jockey Tony Black, who teamed with My Juliet in many

> of her standout races, including the Vosburgh, said he was truly saddened at the news of her passing.

"She provided me with a lot of

great memories that I doubt will ever be equalled," said Black. "She was a great athlete, very versatile, wonderfully easy to ride, like pushing buttons. I've never ridden a sprinter better than her. She was as powerful, as willing and as fast as any horse I've been on — ever."

The filly was owned by George Weasel Jr. and trained for most of her career by Eugene Euster but she was brought to the racetrack and turned into a star by trainer Leland G. Ripley.



Todd Beattie was another winning trainer who offered wholehearted support to state bred stakes, but he insisted he would have believed, anyway, that the initial running of Pennsylvania's Day at the Races was a great idea that deserved to be continued.

He deflected personal credit for conditioning Thomas McClay's Beau's Surprise to win the \$50,000 Lil E Tee Stakes at six furlongs.

"It was a good spot for him," said Beattie after his colt laid off a quick early pace to win in the stretch.

The most dramatic victory of the day might have been produced by the Uriah St. Lewis-trained Arty'svirginiagirl, owned Edward Lane, who rallied four and five wide after falling far back early to easily take the \$50,000 Mrs. Penny Stakes at 1 1/16 miles on the grass.

After watching the six-year-old mare register her first victory on the turf in seven tries, St. Lewis gave the day's briefest, most succinct endorsement of Pennsylvania's Day at the Races.

"I like it."

So did Robert A. Szeyller, President of the Pennsylvania Horse Breeders' Association that staged the six state-bred stakes with a \$50,000 purse for each, after taking in the races and feeling the electricity generated by the crowd.

"We're tickled to death," said Szeyller, "and obviously, we'd like to make this an annual event."

Added to the entertainment mix, of course, was the Gallant Bob Handicap won by Sea Of Green and the Cotillion Handicap, in which Lee Lewis' Mystic Lady captured the 1 1/16 miles race to score her fifth victory in her last ten races, all stakes and all run at different tracks.

The three-year-old filly's performance caused trainer Mark A. Hennig to remark, "She's quickly becoming my favorite filly of all time."

Bob Seeger, a member of the PTHA Board of Directors, might have best illustrated the purpose of the state-bred stakes when his Golden Lake won the Go For Wand Stakes at six furlongs. Seeger's Plumstead Stables owns the threeyear-old filly that he trains and bred.

If the purpose of the day was to encourage the breeding and racing of top notch thoroughbreds, Seeger could have been the poster boy.




RALPH J. DELANEY JR.

A HORSEWOMAN'S GENTLE EXIT

When Jenny Ornsteen was trying to break into horse racing, she learned soon enough that knocking on doors didn't always work. Sometimes they had to be kicked open.

Like when she wanted to be an outrider at Hialeah Park in the 1970s.

A trainer she worked for put in a good word with the general manager of the track.

"Women can't outride," said the executive, who was just repeating a popular, if mistaken, belief of the time.

"You'd better tell her then," said the trainer, "she just caught a loose horse one of your outriders missed."

In a way, she'd been preparing for that moment since she was six years old and began nurturing a dream of riding jumpers in the Olympics.

The dream was abandoned when she was a teenager and boarded a couple of her jumping horses at a farm in Chester Springs that was owned by a horseman who owned thoroughbreds.

He told her she could board her charges for free if she would break racehorses for him.

"I learned this was something I could make a living at," said Ornsteen.

It was the beginning of a 32-year whirlwind career that included dazzling highlights such as serving as an analyst for five years on telecasts of the Breeders' Cup on NBC and a trip to France to help broadcast the famed Prix de l'Arc de Triomphe.

Getting from outrider to TV star was a charmed trip that began when she was an outrider at Arlington Park in Illinois and was an assistant to the announcer on a trackside

breakfast show for fans on weekends.

"The announcer didn't feel well one day and asked me to talk to the fans," said Ornsteen. "As soon as I picked up the mike, I knew I loved it."

She wound up doing the breakfast show three hours each Saturday and Sunday and that led to a handicapping show and finally to doing features with trainer and TV personality Frank Wright on a local CBS show that won an Eclipse award.

She came to Philadelphia Park in 1988, where practically her first words to management were, "How come you don't have a woman doing your TV show?"

If that was her interview, she passed it. She took over the Philadelphia Park Live TV show for simulcasts and it was during this period that she was asked to do the Breeders' Cup telecasts.

It was shortly before her last Breeders' Cup show that she saw a doctor after experiencing a numbness in her neck and learned she was suffering from multiple sclerosis. That was in 1992. She battled through the beginnings of the illness, using an optimistic outlook as a weapon.

"I was told if you went symptom free for 10 years, you'd beaten it," she said.

In 1994, she married Stan James, currently Director of Facilities at Philadelphia Park, and the following year gave birth to a daughter, Fritzi Rose.

She had to give up the TV show to stay home with her child, but racetrack management convinced her to stay on as Publicity Director.

"They've been unbelievably supportive and understanding," she said, citing that she was encouraged to work from home as much as necessary.

"The kind of technology we have today made it possible." said Ornsteen, but she said managing everything became increasingly difficult after her father died and her ailing mother came to live with her and her family. "I'd wind up writing press releases ten o'clock at night after handling family matters all day."

She isn't complaining. She just wants all of her friends and all of the horsemen at Philadelphia Park to understand that her resignation from her job, effective Sept. 4, in no way meant she was unhappy with the choice she made a long time ago to earn her living in horse racing.

Her first and only child is in the first grade at Newtown Friends School. Her mother's health is a daily concern and her own well being is uncertain at best.

It was just time for her to go.

She exits gently through some of the same doors she once was forced to kick open.


It's always time to run TO Him and then to run FOR Him with purpose and dedication. It's a race worth winning. The odds are with God. You can bet on Him.




