On Thursday, May 3, 2007, the Pennsylvania Thoroughbred Horseman's Association's attorneys Pelino & Lentz filed a petition with the Pennsylvania Gaming Control Board officially opposing the proposal by Greenwood Gaming, the owner of Philadelphia Park Casino and Racetrack, to have its temporary facility deemed permanent. The PTHA is seeking to require Greenwood to build the original stand-alone \$300 million casino it committed to during the licensing process. "Philadelphia Park's proposal is unacceptable and is a transparent attempt to avoid the financial investment it committed to as a condition of its gaming license," said Michael Ballezzi, Executive Director of the PTHA. "If the demand for slots at Philadelphia Park is as high as its owners

itain, then it should be making every effort to move ahead with construction of a stand-alone facility that can hold additional slots machines and will provide both slots and horseracing patrons with a complete entertainment experience."

President Larry Riviello said "We must take a stand to make Greenwood Gaming do what is right and fair for the horseman of Philadelphia Park. We've been pushed aside like horse racing doesn't belong here."

On June 5, 2007, the PTHA was granted the right to intervene in proceedings to determine whether the temporary slot-machine facility should be considered permanent. "We are pleased that the Pennsylvania Gaming Control Board granted us the ability to be a party to the consideration of Philadelphia Park's proposal," said Mike Ballezzi. "Making the current conditions at the casino and track permanent would be a disaster. Philadelphia Park made a commitment to the commonwealth, to local residents, and to local governments that it would invest \$300 million in a new facility that would spur economic development and create new jobs. They should not be allowed to back away from that commitment."

The PTHA was happy to receive the news that Greenwood has withdrawn its petition before the Gaming Control Board that sought to have the current facility deemed permanent. Remaining guardedly optimistic, Mike Ballezzi stated, "This is great news if Greenwood Gaming has truly withdrawn the petition and plans to move forward with their original master plan for Philadelphia Park. There has been an outpouring of complaints about their intention to abandon the commitment in a new facility. We hope Greenwood's executives are responding to that concern and intend to adhere to the plans submitted in the original application to the Gaming Board. But given our past experience, we know that things are not always as they seem when Greenwood is involved," says Ballezzi. "I really hope this is not the case, but this could be just a ploy on

have expressed concerns about conditions at the facility, and the horsemen we represent."

Ballezzi noted that Greenwood's legal counsel, at an earlier hearing, expressed concern about being able to meet the deadline of August 10th for the submission of a new master plan. "If they are withdrawing this proposal temporarily just to avoid the deadlines established by the Gaming Board, then Greenwood Gaming is more arrogant than I imagined," said Ballezzi. He noted that Philadelphia Park needs to be pressured to adhere to its original master plan and that Greenwood needs to do more to assist live racing given the delays in constructing a new facility. The PTHA has asked the Racing Commission to hold hearings about what Philadelphia Park is doing to improve live racing given schedule delays in the construction of a new facility, attendance declines at the track, and a significant drop in the live handle.

In other track news, purse increases were announced. Beginning July 14, Philadelphia Park will increase daily purses by almost 20% to about \$210,000 per day.

"With this increase, we tried to address some of our key races," said Director of Racing Sal Sinatra. "For instance, the maiden special weights have gone from \$28,000 to \$34,000, and the first-level allowances race will jump from \$30,000 to \$37,000. We're also pleased that we could bump several of our major stakes as we head toward the fall season."

"Many of our horsemen have labored long and hard to have an opportunity to compete for purses like this," said Mike Ballezzi. "News like this is nothing but positive for both them and their families."

Five stakes will see increased purses. The Turf Monster Handicap slated for September 3rd will go from \$150,000 to \$200,000. The Larry Riviello Presidents Cup run on September 15th will get an identical increase. Two stakes set for September 29th will be see an increase. The Gallant Bob goes \$150,000 to \$250,000 and the My Juliet goes from \$150,000 to \$300,000 (which includes a \$50,000 Breeders Cup bonus). And finally, the Grade II Fitz Dixon Cotillion Handicap, placed on the calendar as a Breeders Cup prep on September 22nd, will offer a purse of \$750,000, up from \$500,000.

Ballezzi noted that one of the keys to maintaining the long-term livelihood of horseracing is attracting younger people to the racetrack by providing a quality product. "One of the major elements of the Pennsylvania Gaming Act was to enhance live horse racing in Pennsylvania," said Ballezzi. "But Philadelphia Park's entire philosophy of treating track patrons as second class citizens, combined with the abysmal conditions, is actually hurting live horseracing. This was clearly not the intent of the legislature or the Governor when they expanded slot machines to Pennsylvania's racetracks."


May 3rd the headlines read, "Horsemen seek to block Philadelphia Park's efforts to have facility deeded permanent". The PTHA filed an official opposition to the Greenwood Gaming, owner of Philadelphia Park Casino and Racetrack, proposal to make the grandstand their permanent facility. Our filing went to the Pennsylvania Gaming Control Board to be heard.

Thursday, May 10th Mr. Paul Spears of the Standardbred Breeders of Pennsylvania prepared the letter to Governor Rendell informing him of the Coalition's position on the merger. The Coalition respectfully advocates that the independence of both racing commissions and their individual executive secretaries be preserved in their present form. The Coalition recommends that the two commissions continue to explore co-operative approaches to common issues such as drug testing and enforcement. The letter was signed by the entire membership of the Coalition.



## Pennsylvania Nationally Recognized In Triple Crown Series 2004-2007

For the fourth straight year Pennsylvania Thoroughbred racing has been put in the national spotlight. In 2004 it was PA bred Smarty Jones, owned by the Chapmans Someday Farms in New Hope PA winning the Derby and Preakness; 2005 saw Afleet Alex, owned by Cash Is King Stables led by Chuck Zacney of Phoenixville PA, who won the Preakness and Belmont; 2006 Derby winner Barbaro was raised on his owners, the Jacksons, Lael Stables farm in West Grove PA. That brings us to 2007.

This year found two PA bred contenders on the Triple Crown trail. The 2006 PHBA champion 2-yr. old, Great Hunter, bred in Pennsylvania by Ivy Dell Stud is 3-4-1 in 10 starts win earnings of \$772,500. Great Hunter finished thirteenth in the Derby, skipped the Preakness and is currently sidelined with ankle chips he sustained while prepping for the Belmont. Trainer Doug O'Neill says he will be back in training after the surgery and an approximate 90 day recuperation.

Hard Spun finished a very close second in the Derby, third in the Preakness and fourth in the Belmont for Pennsylvania owner Rick Porter. With 9 Starts: 5 - 1 - 1, and winnings of \$1,043,470, Hard Spun was bred by Brushwood Stables Elizabeth Moran.





### JACKSONS PRESENT BARBARO STAKES TROPHY



"We're very grateful it turned out the way it did," said Roy. "We're ecstatic that the first trophy goes to Centennial Farms and Michael. I don't think if I had written the script, I could write in any better."

PA-Bred Champion Two Year Old Filly

This veteran won three of seven starts - the G1-NSA New York Turf Writers at Saratoga, the Flatterer S. at Philadelphia Park, and the Marcellus Frost at Percy Warner, while earning \$204,900. 2006 was his second consecutive PA-Bred championship season.

At 3 he was third in the Woodbury Stakes and Iberis Stakes. His winnings totaled \$250,308 in 15 starts: 5 - 1 - 3. A good amount in 2007, but really nice earnings in the 80's.

# HAPLAIN'S ORNER By Chaplain Jack Cordell




#### A BATTLE OF WILLS

Jockeys and exercise riders amaze me. Day after day they mount half-ton animals to use their skill and just plain guts to ride those creatures around the oval at high speeds. But who's in control, the rider or the horse? When I first came to the track, I thought the rider was always in control until I watched some very talented riders on some very difficult horses. To become a winner, the horse must be willing to obey the rider. Of course, this delicate dance includes the wishes of the trainer. If the horse cooperates with the rider and the trainer, surely good things can happen. The will of the horse is crucial. In short, it's often a battle of wills.

Here's another lesson for life from the racetrack. In his prayer to the father, Jesus said, "not my will, but yours be done." Those were not idle words. Jesus was facing death on a cross, but was willing to forego his wishes to obey the will of the father and endure profound suffering for us. The world around us urges us to do our own thing, regardless of how it might impact others or ourselves. If it makes us feel good, we must do it.
