Plans take form

Ten years ago, Larry Riviello, PTHA President, Michael Ballezzi, Executive rector, Sal DeBunda, Vice President, Lobbiest Steve Wojack and Senator hee Fumo began crafting legislation to bring slots to Pennsylvania. They worked tirelessly over the past ten years with the result of improving horseracing in Pennsylvania as their goal.

Tax relief from slots

In 2002, while campaigning, Governor Ed Rendell makes the pairing of gambling revenue with property tax the major issue of his campaign.

Rendell signs Slot Bill into law

Governor Ed Rendell signed laws at Philadelphia Park on Monday, July 5, 2004 allowing 61,000 slot machines in the state at 14 sites, including seven racetracks.

The state's share of revenue from slots will be used to cut property tax rates by about 20%.

"It isn't a panacea, but it certainly isn't the demon it's been made out to be," Rendell, who made slot machines a focal point of his 2002 election campaign, told the Associated Press.

The law will allocate slots to existing and pre-approved Thoroughbred tracks and one new harness track. The four tracks already in operation in Pennsylvania are Philadelphia Park, Penn National Race Course; Pocono Downs harness track, and The Meadows harness track.

Two proposed tracks have been granted licenses-Chester Downs and Marina, which will partner with Harrah's Entertainment Inc., and MTR Gaming's Presque Isle Downs near Erie. Two additional track licenses are still up for grabs.

The licensing process could take up to 1 1/2 years, but racetrack owners will be able to apply for conditional licenses in order to move ahead with construction of slots parlors.

e state House of Representatives approved the measures on the morning of

July 4. The Senate approved the slots bill on July 2 and the property tax measure on July 3.

Following the vote, Sen. Vincent J. Fumo, the Philadelphia Democrat who was one of the bill's chief architects, said that the billions of dollars that Pennsylvanians gamble in other states, such as New Jersey, would come home to roost and create countless jobs. "This is a competitive decision we're faced with, we're keeping our money inside our borders," Fumo said.

Pennsylvania is the 18th state to legalize slot machine gambling, according to the American Gaming Association.

Slots applicants named

PA Gaming Control Board received 25 application submissions for operator licenses. State gambling regulators released a list of hundreds of investors, executives and companies that have a hand in the 25 applications for licenses to operate slot machine parlors in Pennsylvania.

Gaming board adopts tougher ethics code

State gambling officials say a strengthened ethics policy will make their decisions on awarding slots licenses more transparent, guided by due process and less vulnerable to lawsuits.

PA Gaming Control Board approves six manufacturer licenses

The Pennsylvania Gaming Control Board voted unanimously to award licenses to six companies that filed applications to be manufacturers of slot machines and associated equipment. All six licenses are subject to a series of 40 conditions set by the Board to ensure that the requirements of the Pennsylvania Race Horse Development and Gaming Act and Board regulations are met.

Board issues temporary license

On September 27, 2006, Philadelphia Park was granted a temporary gaming license. This will allow work in the Grandstand to move ahead with the installation of 2,000-2,500 slot machines. The slots are expected to be ready for customers to start playing on December 15, 2006.

Riviello President's Cup Stake, \$100,000 Guaranteed was contested on the turf, this was the first time this race was run on the turf at a distance of 1 1/8 miles. I thank Governor Rendell for having the wisdom and foresight to know the importance of slot revenues for the State of Pennsylvania and the horse racing industry.

Thought of the Day

You will discover the truth in time.

From the desk of the Executive Director Michael Ballezzi, Esq.

rhaps it is time to openly debate whether the Pennsylvania orse Racing Commission's application of the Commonwealth of Pennsylvania's zero tolerance drug policy is unnecessarily restrictive, biased, excessively punitive and unjust.

Perhaps it is time to openly acknowledge that the PHRC is enforcing 19th century standards with 21st century technology. Perhaps it is time to openly question the PHRC's zero tolerance drug policy that calls as positive 11 ng/ml of benzoylecgonine (BZE) cocaine, as was recently called by the PHRC laboratory. Perhaps it is time to remind the PHRC that a nanogram (ng) is one billionth of a gram or to put this infinitesimally small amount in perspective, one nanogram can be compared to one second in the life of a 32 year old. Has anyone heard of environmental contamination? Perhaps it is time to ask the PHRC if it can warrant that its detention barns, employees and licensees are drug free and have not contributed to possible environmental contamination.

Perhaps it is time to openly compare PHRC's zero tolerance drug policy with other racing jurisdictions that have established thresholds for drugs above zero when those tolerance levels are shown to be non-performance enhancing. This is the case in Florida, Ohio, California, Louisiana, Illinois, Indiana and other racing jurisdictions which have established 150 ng/ml of cocaine as the minimum threshold to be considered a positive. Perhaps it is time that the PHRC review the rules, regulations

Perhaps it is time that the PHRC review the rules, regulations and laws of the Commonwealth of Pennsylvania that have established less than 150 ng/ml of cocaine as non-actionable for a most security sensitive employees and less than 300 ng/ml or all other Commonwealth employees.

Perhaps it is time to request the PHRC review carefully and thoroughly a drug policy that places at jeopardy the licenses, reputations, and businesses of professional horsemen and horsewomen.

Perhaps it is time to review carefully and thoroughly a drug policy that utilizes the "absolute insurer" rule to hold horsemen completely responsible without an iota of quantitative consideration prior to calling a positive often resulting in loss of purse and unwarranted suspensions and fines.

Perhaps it is time to be clear that the

PHRC is not being asked to diminish or weaken its strong vigilant policy against those who would compromise and ruin our industry through illicit doping practices. But rather to reconsider the policy which calls as positive drug levels which are clearly deminimus and consequently have no effect whatsoever on racing performance, the outcome of a race or the betting public.

It is time that the PHRC adopt a drug policy that is consistent with those racing jurisdictions that acknowledge non-performance enhancing thresholds and withdrawal times as fair, reasonable and in the best interest of racing.


But most importantly, it is time for the Pennsylvania Horse Racing Commission to participate in an open and honest dialogue with horsemen and horsewomen throughout the Commonwealth, free from the cloak and dagger attitude that horsemen are the bad guys and that the Commission is the omnipotent know it all for justice and righteousness.



TAX STRATEGIES FOR POTENTIAL HORSE OWNERS

I. HORSE FARMING - A BUSINESS OR A HOBBY?

A. General Explanation

Section 183 of the Internal Revenue Code (IRC) provides that a taxpayer cannot deduct expenses of an activity, which are greater than the income from that activity if the activity is "not engaged in for profit". In other words, losses from an activity deemed to be a HOBBY cannot be deducted against income from other sources.

In determining whether an activity is engaged in for profit, all facts and circumstances with respect to the activity are taken into account. Although a reasonable expectation of profit is not required, the facts and circumstance must indicate that the taxpayer entered into the activity or continued the activity with the objective of making a profit.

B. Factors Used to Determine Character of the Activity

In determining whether or not an activity is engaged in for profit, the IRS regulations list certain factors, which are to be considered. No one factor is controlling.

- \$ Whether the taxpayer carries on the activity in a businesslike manner.
- \$ The expertise of the taxpayer and his advisors.
- \$ The time and effort expended by the taxpayer in carrying out the activity.
- \$ Expectations that assets used in the activity may appreciate in value.
 - The success of the taxpayer in carrying on other similar or dissimilar activities.
- \$ The taxpayer's history of income or losses with respect to the activity.

- \$ The amount of profits in relationship to losses and to the relationship of the taxpayer's overall investment in the activity.
- \$ Substantial income from sources other than the activity.
- \$ Elements of personal pleasure or recreation.

Tax Tip - If your horse business begins losing money every year for a number of years, and the IRS is auditing your returns, you must be able to demonstrate to the satisfaction of the IRS that this business will be profitable in the future. This requires adequate planning, which should begin well before the IRS decides to audit you.

C. Presumption that the Activity is a Business

The IRS regulations also provide that if a horse activity shows profits in two years during a specified seven-year period, such an activity will be "presumed" to be a business. In the case of a new activity, two profit years during any of the first seven years of operation triggers a presumption that it is a business activity for all of those seven years, provided the taxpayer makes a special election by the due date of the tax return for the third tax year.

Tax Tip - This election should not be made without very careful thought. A number of considerations must be taken into account before such election is made. It is always better to show two profit years, if you can, in a seven-year period, even though the profits are small in relation to the losses. ■



Philadelphia Park Trainers Feature

Be sure to get your copy of the newest book by Irene Coletti, Fallen Eagle. Irene is the mother of trainer Ed Coletti.



STUDENT SCHOLARSHIP AWARDED


