\$1 Million PA Derby Highlights Parx Fall Festival

With the racetrack renovation completed by the last week in August and the first floor of the grandstand returned to a bright, modern area for the horsemen, live racing resumes on August 30. Just one week later, Philadelphia Park's Fall Festival of Racing kicks off five exciting weekends of racing beginning with Smarty Jones Day on Monday, September 6, Labor

Highlighted by the \$1 million Grade 2 PA Derby on September 25, the Fall Festival features increased overnight purses, and stakes races carded in every category.

Owner's Appreciation Day on September 18 offers a 100% increase in overnight purses, as well as an increase to \$500 of pay back to last, up from \$200. The PTHA will provide gifts for owners who have horses racing that afternoon, with the feature race the \$250,000 PTHA President's Cup.

The Festival ends with the Grade 2 \$750,000 Cotillion Handicap and Ladies Day on October 2.



Greenwood Gaming Names DeAngelo New CEO

Former CEO Bill Hogwood has been named deputy chairman under Chairman Bob Green, and is happy to have DeAngelo on board.

"I am delighted to welcome Len DeAngelo as our new CEO and President," said Bill Hogwood. "The addition of Len to our team gives us great confidence in our potential for future growth."

DeAngelo offers 23 years of gaming industry and hotel experience, having served as Executive Vice President of Operations for Penn National Gaming, Inc. from June 2003 to August 2008.

"My first experience with horseracing was at Penn National," said DeAngelo. "Although all operations managers reported to me, I tried to stay in touch with everything that was going on."

DeAngelo said he has jumped into every aspect of Greenwood in just the first few weeks of his appointment.

"Table games were opening up just as I came through the door,

and I see lots of opportunities for both racing and the casino as we continue to develop the property."

It was soon after that DeAngelo got his first look at the Philadelphia Park backstretch.

"I toured the barn area with Joe Wilson the first week in August," he said. "We reviewed the DEP issues, and I believe once the new barn plans are finalized, we will quickly move ahead with completing the backstretch renovations.'


DeAngelo is looking forward to the opening of the first floor of the racetrack at the end of August as a new live racing and simulcasting facility.

"All of the improvements that have been made in the building will give the racetrack more of a presence," he said. "We hope that all of the racing clientele will really love it.

"I think given what we are doing in the grandstand shows we have a long term commitment to racing. With the addition of even more slot machines, we think we can improve the product dramatically."

Virginia Sculptress Re-creates Smarty Jones in Bronze

As a horsewoman, sculptress Jean Clagett pays close attention to the detail on her live subjects before transitioning them into the bronze images that adorn horse parks, private homes, and, as of Labor Day weekend, Philadelphia Park.

Kentucky Derby winner Smarty Jones' triumphant return to the winner's circle after his Classic win is being memorialized in bronze and will be unveiled on Smarty Jones Day, September 6.

Created first for owners Pat and Roy Chapman, and now, at 1/4 life size and without the garland of roses, for the walkway between *parx casino* and the racetrack, Smarty can now be enjoyed by all of his fans every time they visit the casino or the track.

"I believe that the attention to anatomy is critical," said Clagett, who takes care of her own horses in Virginia. "It was a six month project to re-create Smarty, and then see the process through until he was cast in bronze."

Mrs. Chapman made arrangements for Clagett to visit Three Chimneys Farm in Lexington, KY, where Smarty stands at stud, to take measurements of the popular chestnut.

"After the initial sculpture was finished, John Servis offered his approval, although John Clay, from Three Chimneys, suggested that I move one of the legs to make it look more like Smarty," said Clagett.

"I am honored to be able to create something that gives recognition to what Smarty Jones has done for the entire Pennsylvania racing industry."


2010 Facelift For Philadelphia Park

Groom Elite Program Teaches Skills for All Horsemen

Each session is made up of a classroom lecture (right) and a "practical" class. Tex, trainer Randy Allen's lead pony (above) stands for an exam by C. Reid McLellan, Executive Director and instructor of the Groom Elite program.

The PTHA once again sponsored the popular Groom Elite program for licensed personnel. The continuing education program attracted 15 horsemen, from grooms to trainers, who were interested in increasing their knowledge of the horse, and who would receive a certificate after passing the five-week course. The PTHA pays for jackets and t-shirts for all graduates.

Heather Zuniga, age 61 and one of this session's students, has been involved in racing for 44 years, and has handled many different jobs.

"I signed up for the Groom Elite program because I think there is al-

ways something new to learn in this business," said Zuniga. "I have been on the racetrack since 1966, and have done just about everything you can do in racing, but you can never learn too much."

C. Reid McLellan, Executive Director of Groom Elite, conducts the program on dark days. The program, presented in both Spanish and English, is 40% classroom, and 60% hands-on.

ROTH IRAs and 2010

This year 2010 has brought numerous articles in the financial press dedicated to Roth IRA's. This is the magic year in which there are no income limitations on an individual's ability to convert from a Traditional IRA to a Roth IRA. Additionally the federal income tax due on that conversion can be spread out over 2 taxable years 2010 and 2011. So as a trainer or owner of race horses what can 2010, the year of the magic Roth conversion, mean to me?

Let's first review the two key differences between a Traditional IRA and a Roth IRA. With a Traditional IRA, your IRA contribution is deductible and your distribution from your IRA is taxable. Said another way, you deduct it going in. They tax it coming out. The Roth IRA is the exact opposite. You do not deduct it going in. They do not tax it coming out. Your distribution is tax free.

As a trainer or owner you may have tax losses in any given year such that those tax losses offset some part of your taxable income. Thus you pay less tax because your taxable income and your taxable rate is lower. A lower tax bracket as such is an ideal situation in which to contribute to a Roth IRA account or convert from a Traditional IRA to a Roth IRA.

With a Roth IRA conversion you are converting your –or your spouses – Traditional IRA into a Roth IRA. When doing this, your entire Traditional IRA account value becomes taxable as income. However if you are showing any tax losses, those losses can be used to offset the taxable income generated by the Roth conversion. So if you intend to show any losses, with the proper planning and timing, you may possibly be able to convert to a Roth IRA while paying much less federal income tax due on that conversion – if any. In effect, you can use your tax losses today to create tax free income in the future.

Definitely speak with your accountant or your other tax and investment professional. But do it now, before December 31. You may possibly save thousand's in taxes in the future.
