Tuesday, January 30th the Pennsylvania Racing and Breeding Coalition held their third meeting. In attendance: Michael P. Ballezzi, Chairman; Larry Riviello, PTHA President; Joe Santana, Pennsylvania HBPA President; Peter Giangliulo, PHBA President; Todd Mosteller, Executive Director PHBPA; Ronald Battoni, Executive Director PHHA; Mark McDermott, Executive Secretary PHBA; Pete (Paul) Spears, Standardbred Breeders Assn.; Ed Simon, statistician PTHA and Michael Allen, attorney.

Pete Spears from the Standardbred Breeders Association was appointed secretary.

The Health Care and Pension Committee, reported by Ron Battoni and Todd Mosteller, says there is a great possibility of an affordable health plan to cover all horsemen and horsewomen in Pennsylvania. Details are forthcoming.

Michael Allen, attorney, reviewed the Bylaws with the members and reported on the 501(c) (6) application. Mr. Allen filed for a Pennsylvania Non-Profit Corporation.

Chairman Ballezzi updated dues, slot revenue and the Bylaws. The next coalition meeting will be April 30, 2007.

I often wonder what we as horsemen and horsewomen could do to ban the slaughter of horses for human consumption. According to the National Horse Protection website there were more than 90,000 horses slaughtered last year by three foreign owned plants. Bill HR 503 is in place. This Bill would permanently ban the slaughter of horses for human consumption.

Noble Threewitt, my friend from the National Horsemen's Benevolent and Protective Association, will retire on his 96th birthday, February 24th. Noble, a California trainer, became the oldest trainer, at age 95, to win a race in North America when he saddled Threestone to victory at Santa Anita on April 22, 2006.

Noble saddled his first winner in 1932, congratulations and continued good fortune to you and your wife Beryl.

I thank our horsemen and horsewomen who gave up their time and input on all committees. Committees are important to make our organization strong and viable.



Barbaro - A Nation Loses Its Hero

As co-owner, Roy Jackson, said in a previous interview, "Gretchen and I have been so happy to see so many people interested in horse racing and Barbaro, it's so great to have new people involved in this wonderful sport." During that interview he commented on how people that had never been involved or interested in racing were stopping he and his wife at the store, in the post office, everywhere they traveled, to ask how he was doing. This included the public throngs, young and old, that brought carrots, roses, apples and cards to the New Bolton clinic. They prayed for the Jacksons and Barbaro - keeping vigil across the county - reading stories in magazines and newspapers, watching news broadcasts and even getting up-dates on the Internet.

It was a roller coaster ride for those of us keeping this daily vigil. He had good days and great days, bad days and horrible days but through it all he remained our hero. This wonderful horse was valuable in so many ways to so many people. He provided the doctors and staff at New Bolton with valuable data for future catastrophic equine injuries. He drew in new fans to the sport. He brought people and families together as they cheered him on.

Even though Barbaro's valiant fight ended on January 29, 2007 when complications from laminitis became too much for our hero to overcome, he will always be in our hearts. ■

III. PASSIVE LOSS LIMITATIONS - FINAL INSTALLMENT

A. General

If a horse owner does not "materially participate" in a business activity, losses and credits for that passive activity are not allowed as a current deduction. Losses and credits from a passive activity are deductible only against income from other passive sources. Losses, which are not currently allowed, may be carried forward indefinitely and used in later years, or used when the interest in the activity is sold or terminated.

B. Material Participation

Material participation means regular, continuous and substantial involvement. According to IRS, a person who spends at least 500 hours on an activity during the year is deemed to meet the material participation test. An individual who spends less than the 500 hours but more than 100 hours on the activity during the year can also meet the material participation test provided certain other circumstances are met.

Tax Tip - It is important to keep a record of time you spend on your horse operations. You will see that is most likely that you will meet the 100-hour test.

C. What Constitutes a Single Activity

One or more trade or business activities are treated as a single activity if the activities constitute an appropriate economic unit for the measurement of gain or loss for the purpose of the passive loss rules. Whether separate activities are treated as one depend on all the relevant facts and circumstances. The regulations state that the most important factors are (1) similarities in the types of business, (2) control, (3) common ownership, (4) geographical location, and (5) interdependency between the activities.

Tax Tip - Under the IRS regulations, it may be possible to group a passive horse activity, which is losing money with some other passive operation, which is profitable into a single activity thereby utilizing the losses. Another approach is to create separate activities for the various aspects of a "passive" horse operation. This means that completely terminating one of the activities will allow all losses which have not been deducted to be fully deductible in the year of termination. ■

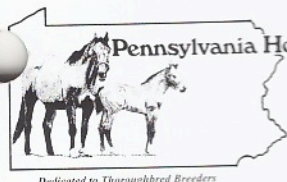

ReRun Plans Fundraiser for Backstretch Workers

Although ReRun, Inc. is best known for helping Thoroughbred racehorses, the 10-year-old non-profit group has organized a fundraiser that will benefit both horses and the people who care for them at Philadelphia Park.

"After speaking with Chaplain Jack Cordell, ReRun has decided to earmark 50% of its donations from a special March fundraiser at the track to the special needs of the people who live on the backstretch," said Executive Director, Barbara Luna. "Although we take in almost 30 horses a year into our program, we felt it was time to give something back to people who spend their lives caring for racehorses during their competitive years, especially when many of these people have so little of their own."

Weekends in March have been designated as "Help Those Who Help Our Horses" days when ReRun representatives will set up near the backstretch kitchen and upstairs in the horsemen's area on the frontside. Donations will be collected and at the end of the month will be presented to the Chaplain to use for workers' transportation to health care facilities and doctors.

ReRun has satellite farms in New York, New Jersey and Kentucky, but takes in horses from any racetrack. With an ambitious 2007 goal of doubling the number of horses accepted into the program, the organization has scheduled a number of fundraisers throughout the summer and fall, including a coach driving event and All-Thoroughbred Horse Show in New Jersey.

"We also mail out two newsletters a year, and continue to seek sponsorships from breeders and owners," said Luna. "We encourage breeders to take part in our 'stickers' program, which enables them to affix a label onto their horses' foal papers giving a name and phone number to be contacted if the horse is ever in need of a home after he is retired."

"Owners can help by donating a percentage of purse money earned to ReRun for one race, or every race," said Luna. "That is our Running for ReRun program."

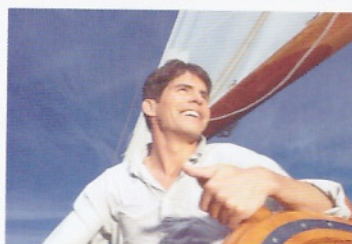
