abor Day weekend 2004 kicked off our two biggest days of our racing calendar here at Philadelphia Park. On Saturday, we hosted "PA Day at the Races", with 5 stakes totaling \$250,000 for registered PA breds. Monday featured 3 stakes worth \$925,000, highlighted by the \$750,000 Grade 2 PA Derby.

clouded only by the absence of our local champion "Smarty Jones". Although he was missed by everyone on hand, his retirement emboldened 12 owners to take a shot at Pennsylvania's richest racing prize. Sal Sinatra and Phil Parker assembled a field which looked quite competitive on paper, but turned into a laugher as "Love Of Money", romped home by 8 1/2 lengths under jockey Robby Albarado. The 3 year old Maryland bred son of "Not For Love" was stretching out off a series of sharp sprints for NY-based trainer Richard Dutrow, and lead from gate to wire. The victory was worth \$450,000 for owners JayEmEss Stable.

The most exciting race of the day

was the \$100,000 Pennsylvania Oaks. "Rainforest", who was pressed on the lead throughout finally opened up a bit of breathing room with about 1/16 of a mile to go under John Velazquez, only to have "Taittinger Rose" and Pat Day join them in the last jump. Even the photo finish camera couldn't

separate these two and the first dead heat in Pennsylvania Oaks history was recorded.

In the \$75,000 Steve Van Buren Handicap, "Smooth Maneuvers" burst to the front like an Eagles running back and rode the speed favoring surface to a front running score under Ramon Dominguez. The Michael Pino trainee posted a half mile split in 44:1 and a 3/4 time of 1:09 but didn't wilt en route to a 1:22:3 clocking for 7 furlongs •


#### PRESIDENT

- A fair and compassionate program of benevolence for those horsemen in need through the implementation of the Preferred Health Care and individual HMO and major medical health care.
- 6. Also, pursue federal protections for horsemen regarding simulcast signals and wagering hubs.

- Reduce training costs and the daily discomfort that horsemen experience with the continued feed and tack co-operative program, the construction of a PTHA managed equine swimming pool, and oversight of construction of the new training track.
- Coordinate the PTHA and the Pennsylvania Breeders to ensure that the breeders receive
  the maximum incentive to provide quality Pennsylvania Breds for participation in live racing
  at Philadelphia Park.
- Develop a benevolent health insurance program among all area racetracks that ensures uninterrupted health coverage for horsemen as well as establish regulations for Trainer Pensions from new expected revenues.
- Establish acceptable tolerance levels of therapeutic medications, which will allow the proper care and treatment of the racehorse without enhancing racing performance.

I am currently a director of the Pennsylvania Thoroughbred Horsemen's Association. I train horses at Philadelphia Park twelve months a year.




"PA Day At The Races" was certainly a big hit. The betting voucher drawing again proved popular and the buffet lunch was enjoyed by all.
