Final Thoughts: Mary was insistent on expressing her gratitude to everyone who voted for her. "You won't be disappointed", she says with a smile. "I'm not going to let you down. Thanks for the support and voting me on the board."

#### Scott Lake

*Philosophy:* I can't accept failure. I want to win. Second best is just the first loser. So I work hard, and surround myself with hard workers. Believing in a team approach.

I'm open minded. If I don't think something is right I am going to stand up for my beliefs. You don't have people protecting you in here like there are outside the track. I'm going to do everything I can to protect the horsemen.

He's been in horse racing since he was about 12 years old. Leading trainer in the country 4 of the last 5 years in races won. Over the last 3 or 4 years, he figures he trains on average about 200 horses a year. What does he feel makes him good as a trainer? "That competitive edge is what makes me good, and I try to instill that in the guys around me."

At the same time, he tries to keep his head about him. He's not an arrogant person who thinks he's better than anyone else because of the success they've had. While Scott may win his share of races, he feels it is important to be humble.

#### Semi-Annual Medical Services Report

(July 27th through Dec 28th)

#### From the La Salle Neighborhood Nursing Center

During this period the nurses at the clinic provided 435 individual encounters and enrolled 9 new clients. Weekly screening for hypertension reveals a continuous problem. A constant 12% of the clients screened have high blood pressure. Twelve clients were referred to Dr. Rizen for medication to control their hypertension. An additional client was referred to primary care for specific hypertension needs. Flu shots were not available from the health department this year. Education specific to avoiding e transmission of upper respiratory messes was promoted throughout the fall and early winter. Additionally, five clients were counseled on health appropriate measures to reduce infection

and referred to an appropriate medical

provider. Vulnerable populations of the backstretch include the Spanish-speaking clients. Selina Doncevic, MSN, PHN, who is fluent in Spanish, addresses some of the needs of the Latino workers. Other risks for your workers include tetanus infection and undiagnosed diabetes. The La Salle Neighborhood Nursing Center will incorporate these needs in planning for future interventions. This unique model of prevention and wellness continues to assist your workers to be fit and productive.

Accomplishments

Total enrolled: 258 (153 Caucasian, 10 Black, 95 Hispanic)

Total encounters: 435

Referrals for additional health care: 18 New enrollees: 9

Identified needs: Immunization up-dates for tetanus, and Glucose screening for diabetes.

#### Barriers:

Unfortunately, due to federal and state limitations, influenza vaccine was unavailable for use at the backstretch of the racetrack. Those with highest risks were sent to private doctors or to public venues for immunization. By individual report, those without access to private health care did not receive vaccination. La Salle nurses continued to call area vendors to procure access to flu vaccine for racetrack workers. The La Salle Neighborhood Nursing Center plans to offer influenza vaccinations to the racetrack staff in the fall of 2005.

# EMPLOYEE OR INDEPENDENT CONTRACTOR?

If you enjoy confusion and controversy, then you will really love reading IRS Regulations and Interpretations of "Independent Contractor".

The determination of whether an individual is an employee or independent contractor is very much dependent on the facts and circumstances of each case.

What's at stake? Well, a lot really.

The tip of the iceberg is the with-holding and reporting of employee taxes. Then there is the cost of the employer matching of Social Security and Medicare. Below the surface are considerations related to who is included in employer sponsored retirement plans and other employer fringe benefit offerings not to mention (but extremely important) workmen's and unemployment compensation liability and a host of legal issues that can only be addressed by an attorney who has expertise in the employer-employee arena.

In simple terms, IRS Regulations distinguishes between employee and independent contractor by applying this standard:

#### Employer-Employee:

Employer says this is what you need to do and this is how you are to do it. The employer does not have to directly supervise the work but has the right to do so.

- **a.** The employer has the right to fire the individual
- **b.** The employer provides a place to work
- **c.** The employer provides tools and supplies necessary to do the job.

Congress stepped in and provided

some relief to all the confusion involved in interpreting the IRS Rules and Regulations. So understand and apply these "safe harbors" to your particular situation.

A taxpayer has a reasonable basis for not treating an individual as an employee if the taxpayer relied on any one of the following:

- · A Court Case or IRS Ruling
- · A past IRS audit that, under similar circumstances, the IRS did not raise the issue with you.
- · A long standing recognized practice of a significant segment of the industry in which the taxpayer is involved treats the individual in the same manner (pay close attention to this one!)

Now to take advantage of these "safe harbors" you must:

- 1. File all 1099's (information returns) required
- 2. Treat all individuals consistently

#### IRS ADVICE:

Ask IRS to determine the proper treatment. They have a Form SS-8, "Information for use in determining whether a worker is an Employee for Federal Employment Taxes and Income Tax", for this purpose.

#### My ADVICE:

Consult with your tax advisor before requesting such a determination and, file all required 1099 Forms complete with social sequrity numbers and addresses. Without 1099 forms, you are fighting this duel with an unloaded weapon. Get the social security number and address right up front



### FUTURE LOOKS GOOD FOR RACING IN PENNSYLVANIA

Imagine two years from now when Philadelphia Park racing is competitive with that in New Jersey, Delaware, and even New York, when the fields are full and often classy and when \$400,000 is a daily purse average.

Mike Ballezzi, executive director of the Pennsylvania Thoroughbred Horsemen's Association, believes the revenue that slots inject into purse will ensure Philadelphia Park's lofty status. He can't wait.

Purses already have been raised several times in the last year in anticipation of slots revenue and are about \$145,000 daily, including bonuses. Ballezzi said that if the track receives a conditional gaming license this spring, which would boost purses by an additional \$30,000 daily, slots could be active in Bensalem by March 2006.

Plans call for the first floor to be restricted to casino play, with the second and third floors available for watching live racing and simulcasting. When construction begins, the paddock will be moved to the present location of the picnic area.

The improved quality of racing would seem likely to force some marginal stables to move to other locales, but Ballezzi is an optimist on this issue "I'd predict we don't lose one traine Ballezzi said. "The people who have supported us all along should continue to make a decent living."

letti, and his name is "Two By Ten", from the names of his sire and dam.

Now that they are reunited, they seem inseparable. As Tony tells me all the details, it is obvious he loves his son immensely. It sounds like they are always on the phone now. His grand-children even call him to say good night, and tell him they love him. With a tear in his eye Tony Galetto tells me he is hoping for a long life to spend as much time as possible with his son, daughter-in-law, and grandchildren ■
